WALK-IN INTERVIEW FOR THE POST OF SENIOR RESIDENT (Psychiatry)

Deep Chand Bandhu Hospital invites application for a Walk-in-interview for filling up **FOUR (04)** vacant post of Senior Residents (PSYCHIATRY), **three (3) in DCB Hospital and one (1) in Dr. BSA Hospital, Rohini for Adolescent and Juvenile Deaddiction Ward**, on contractual basis. Only candidates who fulfil the eligibility criteria as per Residency Scheme may appear before the interview panel on **18-05-2017 from 9:30 A.M. to 12:00 NOON** with their original documents along with the photo copies of the following documents:-

1. **Qualification** : As per residency scheme: MBBS with Post Graduate Degree in Psychiatry/ or Diploma in Psychological Medicine from a recognised university/ institution. Candidate having 3 or 2 years' experience as Junior Resident in Psychiatry department/speciality may also apply for the post of Senior Resident.
2. **Tenure**: The tenure is initially for a period of one year which shall be extended subject to approval of the competent authority.
- 3 **Age limit**: 35 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only).
4. **DMC Registration Certificate.**

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the **relaxation of provision** as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxation :-

1. Upper age limit for eligibility for SR will be 40 years.
2. In case of non-availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Residents also be allowed to appear in the interview.
3. Separate merit lists for fresh candidates and for other (i.e. those who have competed 3 years of Sr. Residency) would be prepared.
4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
5. Reservation of Person with Disability will be as per Government Rules.

- (1) Self attested photocopies of certificates/testimonials/documents must be submitted and the candidates are required to bring originals along with, for verification in support of details submitted in the application.
- (2) Corrigendum, if any, shall be posted only on website.
- (3) No correspondence or personal enquiries shall be entertained.
- (4) No TA/DA will be paid for the interview.
- (5) The candidates selected will be required to undergo medical examination for fitness in their respective hospitals of posting before joining.

OTHER CONDITIONS OF RECRUITMENT (Senior Resident):-

1. The tenure of Senior Resident (Psychiatry) is initially for a period of 01 year which shall be extended subject to approval of the competent authority.
2. Other service conditions as prescribed from time to time by the GNCTD will be applicable.
3. The candidate who are already in Govt. service should submit NOC.
4. Their service will be governed by residency scheme.
5. Separate merit lists for fresh candidates and for others (those who have completed three years of residency) would be prepared.
6. Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and the second list would be used only after that.
