EMPLOYMENT NOTICE

Applications on prescribed format are invited for eight (8) posts of Stenographers Grade-III on ad-hoc basis, on 50% of initial pay (Pay in the Pay Band i.e. 7440/-+Grade Pay i.e. 2400/- + DA) of fresh entrant regular employee after 01.01.2006 or on the wages fixed by the Deputy Commissioner, Kurukshetra under the Minimum Wages Act, whichever is higher, for a period of six months or till regular appointments are made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, whichever is earlier, so as to reach in the office of the undersigned on or before 20.05.2017 upto 4.00 p.m. The number of posts may increase or decrease on account of creation or withdrawal of Courts. ESSENTIAL QUALIFICATION

The applicant should possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized university and must have proficiency in operation of computers (word processing and spread sheets). The applicant should fulfill the condition of qualification on the last date of receipt of application.

AGE LIMIT

The applicant should not be less than 18 years and more than 42 years of age as on 01.01.2017.

MODE OF SELECTION

The applicant shall have to pass a test of 80 w.p.m. in English shorthand and 20 w.p.m. in transcription of the same on computer. He/she shall also have to qualify Computer Proficiency Test (Word Processing and Spread Sheets). Marks of Computer Proficiency Test would not be counted towards the final merit as it is qualifying in nature. Select list will be prepared on the basis of merit.

DATE OF EXAMINATION.

The applicants who fulfil the aforesaid qualification for the post of Stenographer Grade-III will be required to appear for Shorthand Test/Computer Proficiency Test in the **DISTRICT COURTS, KURUKSHETRA**. Date of Shorthand Test/Computer Proficiency Test will be

notified on the website of District Courts, Kurukshetra i.e. www.ecourts.gov.in/kurukshetra/history. Separate call letters and messages for appearing in Shorthand Test/Computer Proficiency Test will be sent to the applicants.
