One post of Senior Resident will be reserved for Person with Disability candidate as per Govt. Policy.

2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS:-

- A. **Qualification:-**
MBBS with Post graduate degree/ DNB/ Diploma or equivalent as per Residency Scheme in concerned specialty from a recognized University/Institute.
- B. **Age:-** Below 35 years, **On Date of Interview**, shall be for General candidates, 5 years relaxation for SC/ST and 3 years in case of OBC candidates (**OBC belonging to Delhi only**). Persons with disabilities shall be given relaxation as per Govt. of India Rules.
- C. **Pay :-** Basic of **Rs. 67700/-** in Pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- D. The candidate must have completed internship and have valid registration with **Delhi Medical Council**.

- E. Candidate must not have completed three years Senior Residency from any Govt. Hospital. (*)
- F. Appointment will be initially for the period of one year and will be extendable further on yearly basis up to maximum of 03 years on the basis of satisfactory work & conduct report from concerned HOD and a written request by the Official.
- G. Appointment will be subject Medical fitness and verification of certificate of educational qualification /age /caste /DMC registration and Internship completion certificate etc.
- (*) Further in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation:-
 - H. Upper age limit for eligibility for SR will be 40 years.
 - I. In case of non availability of fresh candidates, the candidates who have completed 3 years of Senior Residency may also be allowed to appear in the interview as fresh candidates.
 - J. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
 - K. Firstly, the list containing names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.
 - L. Further, all Senior Residents appointments from second list will be for one year only, for those who have already completed three years of Residency. **It would not be renewable after one year.**

3. CONDITION FOR RECRUITMENT:

- A. All the eligible candidates should report in the office of the undersigned at 9.30 AM. [Time for enrollment from 9.30 A.M. to 11.30 A.M. only] on the day of interview. **No candidate will be entertained after 11.30 AM.**
- B. For candidates applying for OBC category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. Persons with disabilities shall be given relaxation as per rule.
- C. The number of vacancies may vary.
- D. **No TA/DA will be given for appearing in the interview.**
- E. Candidate must submit their Application Form with self attested copies of certificates and should carry original documents for verification at the time of interview.
- F. The list of selected candidates will be available on the website www.health.delhigovt.nic.in under the link "vacancy and result".
- G. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
- H. The services of SRs' will be governed by Residency Schemes of Govt. of India/Civil Services (Temporary Rules).
- I. Candidate who is already in Govt. Service should submit **No Objection Certificate** from the employer at the time of interview.

- J. Jurisdiction of Dispute- In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.
- K. Candidates who are presently working on Adhoc Basis in this Hospital will have to apply afresh in response to this advertisement.
