Applications received thereafter will not be entertained.

1. Applications are invited from Indian citizens (male & female) for filling up the post of Rifleman (General Duty) under Sports Quota for the year 2017 in Assam Rifles, Government of India, Ministry of Home Affairs. Selected candidates are liable to serve anywhere in India or outside the territory of India and will be governed by Assam Rifles Act and Rules. Recruitment Rally will be held at Laitkor, Shillong (Meghalaya), NRS - Guwahati, from **30 September 2017** onwards.

(b) Only Matriculation certificate or Higher Secondary School Certificate will be accepted as a proof for establishing age of the candidates.

(c) The candidates must fulfil all eligibility conditions and should be in possession of all certificates.

(d) All educational sports qualification certificate other than Central Board/ State Board should be accompanied with Government notifications declaring the equivalence of such qualification for service under Central Government.

(e) The candidates seeking relaxation under SC/ST/OBC category should submit the certificate as per prescribe format. In the event of non-enclosure of the certificate, the candidate will be considered under General (UR) category. Any applicant doesn't fulfil the prescribed eligibility conditions, his/her application/candidature will be summarily rejected.

7. No TA/DA or other expenses for appearing in the recruitment test will be paid to the candidates. The candidates should come duly prepared for a stay of at least one week under their own arrangement at the recruitment venue.

8. Selection Process.

(a) Documentation. All candidates will have to go through documentation, in which candidates will have to produce all original documents/ certificates pertaining to age, education, caste, sports activities (National/International), proof to avail age relaxation etc. the details are given in the application form to Board, failing which the candidate will be disqualified.

(aa) The body weights are given this chart corresponding to only certain heights (in Cms) in on even numbers only. In respect of heights in between, the principle of '**Average**' will be utilized for calculating body weights.

(ab) For calculating average weight beyond the heights tabulated, 0.71 Kg for every one Cm of increase or decrease in height may be added or subtracted respectively.

(d) **Detailed Medical Examination (DME)**. The candidates who qualify in the Physical Standard Test will be put through for Detailed Medical Examination (DME). The Medical Standards is as under:-

(ii) The candidates must not have knock-knee, flat foot, varicose veins, squint in eyes and they should possess high colour vision. The candidates will be tested for colour vision by ISIHARA's test as well as Edrioh Green Lantern test.

(iii) Must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of their duties.

(iv) **Criteria to Determine Permissibility of Tatoo**. The practice to engraving/ tattooing in India is prevalent since time immemorial, but has been limited to depict the name or a religious figure, invariably on inner aspect of forearm and usually on left side. One the other hand the present young generation is considerably under the influence of western culture and thus the number of potential recruits bearing skin art had grown enormously over the year, which is not only distasteful but distract from good order and discipline in the force.

(aa) **Content**. Being a secular country, the religious sentiments of our countrymen are to be respected and thus tattoos depicting religious symbol or figure and the name as followed in Indian army, are to be permitted.

(ab) **Location.** Tatoos marked on traditional sites of the body like inner aspect of forearm, but only LEFT forearm being non saluting limb or dorsum of the hands are to be allowed.

(ac) **Size.** Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

**Note:-** The candidates will be examined as per the Revised Medical Guidelines May 2015 issued by ADG (Medical) CAPF, NSG & AR.

(e) **Appeal against Findings of Detailed Medical Examination.** If a candidate is declared UNFIT in the Detailed Medical Examination (DME), the grounds for rejection will be communicated to him/ her by the Presiding Officer. If the rejected candidate is not satisfied with the findings of the Medical officer, he/she will obtain Form 1, 2 & 3 from the Presiding Officer of Recruitment Board concerned to prefer an appeal for Review Medical Examination **within 15 days** from the date of issue of communication in which the findings of the Medical Officers is communicated to him/her. The appeal should necessarily contain the following (a) Review Medical Examination Fee (Rs 25) non-refundable through a IPO in favour of concerned authority to be intimated by the Presiding Officer of Recruitment Board and (b) Appeal Form 1, 2 & 3 issued by the Initial Medical Board declaring the candidate as Unfit. Fitness certificate other than Form 3 (provided by the Presiding Officer of Recruitment Board to the candidate) will not be considered for Review Medical Examination (RME) and appeal will be rejected straightway. The fitness certificate on Form 3 is essential to consider his/her case for Review Medical Examination and not for any other purpose.

(f) Those candidates whose appeals are found in order will be issued call letters to appear for Review Medical Examination (RME) and their list will also be uploaded in the Assam Rifles website [www.assamrifles.gov.in](http://www.assamrifles.gov.in).

(g) The decision of the Review Medical Examination Board will be final and no second appeal will be entertained as per instructions of the Government and no reply of the correspondence / second appeal will be given/ entertained.

**Note:-** Being declared FIT in Medical Examination will in no way given any legal claim or right to any candidate for final appointment in Government service.

9. **Final Selection.** Final selection will be done on the basis of Field Trials and achievements.

10. **Order of Preference.**

(a) First preference to those candidates who have represented the country in an International Competition with the clearance of the Department of Youth Affairs and Sports.

(b) Next preference may be given to those who have represented a State/UT in the Senior or Junior level national Championships organized by the National Sports Federations recognized by Department of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions upto 3rd place. Between the candidates participating in Senior and Junior National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference.

(c) Next preference may be given to those, who have represented a University in an Inter University competition conducted by Association of Indian Universities/ Inter University Sports Board and have won medals or positions upto 3rd place in finals.

(f) Next preference may be given to those who represented a State/ Union Territory/ University/ State Schools Teams but could not win a medal or position, in the same order of preference.

(d) Next preference may be given to those who have represented the State Schools in the National sports/ games for Schools conducted by the All India School Games Federation and have won medals or positions upto 3rd place.

(e) Next preference may be given to those, who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.

**General Instructions.**

(a) Only eligible candidates may apply in the prescribed proforma. Candidates should minutely go through all the provisions in the notification to ensure that he/she is eligible for the post for which he/she is applying.

(b) Candidates should bring all original documents i.e, matriculation pass certificate, sport achievements certificates etc. alongwith self attested Photostat copies of the same at the time of documentation, failing which candidates will be rejected in the documentation stage of recruitment.

(c) The application form must be filled carefully and signed by the candidate in his/ her own handwriting. Correction, if any, should be legible and attested by the candidate.

(d) Assam Rifles will not be responsible for postal delays.
