Essential Qualification.	Peon:- The applicant should have passed Matriculation Examination or its equivalent from recognized Board of School Education/Institution. Basta Bardar:- The applicant should have passed Middle Examination or its equivalent from recognized Board of School Education/Institution.
Desirable.	The applicant should have knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the State. The Medical Certificate issued by the competent authority is essentially required in respect of posts of persons with disabilities.
Age limit.	Between 18 to 45 years (as on 01-07-2017). The upper age limit is relaxable for SC/ST & other categories of persons to the extent permissible under the H.P. Government.
Application Fee:-	Rs. 100/- for General category and Rs. 50/- for SC/ST/BPL/OBC/IRDP and WFF etc. Note: - Ex-servicemen and persons with disabilities are exempted from application fee.

Note:-

The application alongwith the relevant supporting documents as prescribed by the Government vide Notification No. Per(AP.B)B(15)-5/2014 dated 17-04-2017 should reach in the office of the Deputy Commissioner, Shimla, District Shimla-171001 on or before **07/10/2017**. The applications received after the last date or found incomplete will be rejected and no correspondence in this regard will be entertained. The fee should be paid in the shape of crossed IPO in favour of DEPUTY COMMISSIONER SHIMLA. The payment of fee in cash or by any other mode is not acceptable. A separate Application form should be filled for each post and only one application may be sent in one envelope. No TA/DA will be payable to the applicants for appearing in Screening Test/Viva-Voce Test. Selected candidate will be posted in the establishment of Deputy Commissioner, Shimla and the subordinate offices in District Shimla, H.P. In case there is any decrease in the norms of posts the same will be filled accordingly. The candidates can download the application format from the official website of Deputy Commissioner, Shimla.

For already notified vacancies by the recruiting authorities prescribing personal interview, which have not been completed as yet, either the posts shall be re-advertised to the extent of dispensing with the personal interview and parameters as above may be adopted OR selection process shall be completed by 31-05-2017 by the respective recruiting authorities. In case(s) where advertisement for filling up of vacancies has been issued by the recruiting agencies but the written examination hasn't been held in such cases, the recruiting agencies will issue supplementary advertisement immediately clarifying that after written examination no interview will be held and the above parameters will be applicable for selection.


