Recruitment for the Post of Assistant Engineer (Electrical), Assistant Engineer (IT), JE (T&D-Network), JE (Electrical), Chartered Accountant and Line Attendant Batch- 2017 on Contract Basis.

The Madhya Pradesh Vidhyut Vitaran Company Ltd Bhopal is a Successor Company of Madhya Pradesh State Electricity Board. The Company is incorporated to undertake activities of distribution and retail supply of

Electricity in the geographical area of Bhopal, Narmada Puram, Gwalior and Chambal commissionaires. The Company intends to recruit following posts on Contract Basis for an initial period of Contract of 3 years. The category wise vacancies are given is as under against each post:-

1. Reservation:-

- a) The provisions of reservation as per Madhya Pradesh LokSeva (AnusuchiJatiyon, Anusuchitjan Jatiyonaur Anya PicharavargkeliyeArakshan) Adhiniyam 1994 and the rules made there under shall be complied with.
- b) The reservation of position shall be applicable only for the candidates having caste certificate issued by SDO (R) of Madhya Pradesh State.
- c) The candidates of OBC category have to submit income certificate of last three years income of their parents issued by tehsildar in the current financial year.
- d) 33% horizontal and compartment wise reservation for Women will be provided for Assistant Engineer (Electrical) (On Contract Basis), Assistant Engineer (IT) (On Contract Basis), and Chartered Accountant (On Contract Basis).
- e) As per the relaxation given by the GoMP vide memo C3-8/2015/Ek-3dated 15.06.2017 there will be no women reservation in the cadre of Line Attendant and in the cadre of Junior Engineer (Electrical) (On Contract Basis), Junior Engineer (T&D-Network) (On Contract Basis) 20% horizontal and compartment wise reservation for Women will be provided.

How to apply:-

- The candidates can apply through MP online portal only (www.mponline.gov.in) or using the link provided on MPMKVVCL Bhopal website "www.mpcz.co.in".
- ii) The scanned copy of following documents shall be uploaded by the applicant:-
- (a) Aadhar Card
- (b) GATE Score card which must be valid as on dtd.01.07.2017 for the Post of AE (Electrical) (i.e. 2015, 2016 or 2017).
- (c) High School certificate/mark sheet in support of Date of Birth.
- (d) Higher Secondary/ Diploma certificate.
- (e) Certificate or mark sheet of graduation/diploma from recognized university/Board).
- (f) Caste certificate (Permanent), in case of reserved category candidates issued by Sub Divisional Officer of MP Only in prescribed format.
- (g) MP Domicile certificate issued by competent authority in case of candidates applying against reserved positions and also for UR candidate for cadre (Line Attendant where MP Domicile is a mandatory condition.
- (h) Applicant serving in MPSEB or its successor companies should submit post qualification work experience certificate in the relevant field issued by the official (not below the rank of DGM) on the format of which is available on Company's website.

4. Application fee and other charges:-

- i) AE (IT), JE (T&D-Network), JE (Electrical), Chartered Accountant and Line Attendant on Contract: The recruitment shall be done through On-line exam. Application fees for unreserved/OBC candidate of MP domicile and candidates of all categories belonging to other states shall be Re.1500/- per candidate and application fee for SC/ST candidates of MP Domicile shall be Rs.1000/- per candidate.
- Score. Application fees for unreserved/OBC candidate of MP domicile and candidates of all categories belonging to other states shall be Rs.300/-. Application fee for SC/ST candidates of MP Domicile shall be Rs.200/- per candidate. Payment of application fee can also be made in cash in MP Online KIOSK.
- iii) No Extra charges shall be payable for scanning of photographs etc. to the KIOSK apart from the portal charges.
- iv) After payment, one time edit facility will be available to the candidates for which portal charges will be Rs.60/-

- b) Candidates belonging to SC/ ST/ OBC categories and women candidates having M.P. domicile, Ex-serviceman shall get relaxation in upper age limit to an extent of five (5) years.
- c) The candidates who have experience of working on regular or contract basis in any successor company of MPSEB shall be given age relaxation in Upper age limit equal to number of completed years of experience, subject to maximum 5 years.
- d) However, maximum age limit including all relaxation shall be 45 years.

6. Selection Procedure:-

- i) The online academic assessment test shall be conducted by MP Online at various test centres of Bhopal, Gwalior, Jabalpur, Indore only. The number of cities for online academic assessment test can be increased or decreased depending upon number of candidates.
- ii) AE (Electrical):- (a) The selection will be done on the basis of VALID GATE SCORE CARD (i.e. 2015, 2016 or 2017) in Electrical Engineering for AE(Electrical) and weightage of experience for working in any successor company of MPSEB on regular or Contract basis as AE or JE.
- (b) Weightage of experience @ 4% per year maximum of 20% for 5 years or more experience will be given on pro rata basis for working as AE and 2% per year maximum of 10% for 5 years or more experience of working as JE on regular or contract will be given to the candidates. Weightage marks will be given as percentage of total marks of GATE exam.
- (c) Merit List will be prepared by MP Online adding 80% score of Gate Score and the weightage of experience.
- iii) AE (IT), JE (T&D-Network), Chartered Accountant, JE (Electrical) and Line Attendant On Contract:-
- iv) (a) The recruitment shall be done by conducting online examinations of 100 objective type questions (3 marks each) with total 300 marks, no negative

marking for wrong answers will be done. The online examination will be conducted by MP Online.

- (b) The weightage of experience will be given to the candidates having experience in the relevant field in for working in any successor company of MPSEB on regular or Contract basis on equivalent post. Weightage of experience @ 4% (15 marks) per year maximum of 20% (75 marks) for 5 years or more experience will be given on pro rata basis.
- (c) In the recruitment of AE (IT), the weightage for experience of working as JE on regular or contract shall be given @ 2% (7.5 marks) per year maximum of 10% (37.5 marks) for 5 years or more will be given to the candidates.
- v) Linc Attendant on Contract:- The candidates of Line Attendant shall have to pass a Physical test apart from online test as per point 6 (iii) above for getting selected as LA on contract. The Physical test will comprise of walking one km carrying 15 kg weight in 10 minutes and climbing up & down pole with the help of ladder with tool kit rope swing in 2 minutes.
- vi) The merit list will be prepared by MP On-line. Based on the merit list, candidates will be called for verification of original document. After successful verification of documents the candidates will be given appointment order as per the company's policy.
- vii) If the marks secured by two or more candidates are same, selection will be based on the date of birth in descending order i.e. older candidate will be placed first in the merit list and In case of same date of birth, preference will be given to candidates securing higher marks in the qualifying exam. In a situation when both the above conditions are similar for more than one applicant, then preference will be given to candidates securing higher marks in the 12th Board Examination. For JE (T&D-Network)/JE (Electrical)/LA 10th Board marks shall be compared.
- viii) The validity of the waiting list shall be one year from the date of declaration of result. However, the recruitment process may be closed for operation of waiting list by issuing specific order even before one year. After issuance of specific order of closure of the process, the claim of any candidates shall not be entertained.
- ix) The minimum qualifying marks in the online academic assessment test shall be 55% for Unreserved/OBC category candidates and 45% for SC/ST/Handicapped category candidates of MP Domicile.

10. General conditions:-

- i) The Candidates should be an Indian National.
- candidates working in the Government/Semi-Government/ Public Sector, satisfying the eligibility criteria of education and age shall have to produce N.O.C. from their present employer at the time of failing application form, which they shall not be permitted to appear for the interview.
- iii) The GATE SCORE CARD of 2015/2016/2017 will only be considered as valid.
- iv) Company reserves the right to verify document submitted by the applicant. If any of the information given by the applicant is found incorrect, his/her candidature will be cancelled at any stage of selection /appointment and thereafter.
- v) Age relaxation for ST, SC and OBC having caste certificate of SDO (R) of MP, and women having MP domicile, Ex-servicemen will be as per government rules.
- vi) The reserve category candidates selected in merit availing relax standard shall be considered against vacancy of the respective category
- vii) The appointment letter to the candidates will be issued on the basis of merit list subject to verification of original documents.
- viii) The candidates who have a third child born on or after 26.01.2001 are not eligible to apply unless twins are born after first child.
- ix) If any of the information given by the candidates is found incorrect, his/her candidature will be cancelled at any stage of selection and appointment.
- x) The candidates shall be required to work anywhere in the jurisdiction of company.
- xi) However candidates will be asked to Submit Circle wise preferences for posting but the company will not be bound to post the candidates as per their choices. The candidate can be posted anywhere in the company area and no claim on this ground will be entertained.
- xii) On selection initial offer letter will be sent to the candidates by through email on their registered email id and the candidates will be called for document verification.
- xiii) After Document verification of the selected candidates as per merit list the candidates will be given appointment order as trainee and they will be given at

least 15 days time to join at the place of posting failing which their appointment will be stand cancelled and waiting list will be operated.

- xiv) Candidates will not be given reimbursement for to and fro journey for verification of documents or joining at the respective place of posting.
- xv) Once a candidate joins the Company no request for inter company transfer will be entertained.
- xvi) Any dispute arising out of the selection process shall be dealt within the jurisdiction of court situated at Bhopal only.
