Examination will be conducted on OMR Answer Sheets each question carrying one mark (OBJECTIVE TYPE MULTIPLE CHOICE). Duration of question paper for all posts will be two hours. The minimum qualifying marks of Written Exam for General & OBC Category is 45% and for SC/ST Category is 40%. However, number of candidates to be called for second phase examination (i.e. PST, PET, documentation, Trade Test and MET) may be restricted to the ten (10) times the number of vacancies advertised in each category or number of qualified candidates whichever is less. Candidate who do not fill or wrongly fill the mandatory field in OMR Answer Sheet will be declared as non-qualified during evaluation of OMR Answer Sheet.

Candidates are not permitted to use Mobile Phone, Calculator or any other electronic/electrical device for answering any paper (Test Booklets). Candidates will require to undergo Physical Standard Test before Board of Officers. Candidates shall be screened and only those who satisfy the minimum physical standards as per Para-III above shall be allowed to appear for the PET.

Candidates declared disqualified in Physical Standards, i.e. height and chest, may prefer an appeal immediately at the venue of the PST itself, if they so desire, to the Appellate Authority, present on the PST/PET ground. The decision of the Appellate Authority will be final and no further appeal or representation in this regard will be entertained.
