It is proposed to fill up vacancies in the following ranks in the Intelligence Bureau under the Ministry of Home Affairs on deputation/absorption basis. The educational qualification, experience and other eligibility conditions for the posts are as below:

(1) Deputy Central Intelligence Officer/Executive (80 vacancies), General Central Service (Group-A), Gazetted, Non-Ministerial, in level 10 of the Pay Matrix (Rs. 56,100-1,77,500).

Eligibility: Deputation/Absorption:-

Officers of the Indian Police Service or Central Govt. or State Govt. or Union Territories Administrations or Central or State Police Organisations:

a) (i) holding analogous posts on regular basis in the parent cadre or department; **or**
(ii) with 2 years' service in the grade rendered after appointment thereto on regular basis in level 8 (Rs. 47,600-1,51,100) in the pay matrix or equivalent in the parent cadre or department; **or**

(iii) with 3 years' service in the grade rendered after appointment thereto on regular basis in level 7 (Rs. 44,900-1,42,400) in the pay matrix or equivalent in the parent cadre or department; **and**

(b) possessing the following educational qualifications and experience:

(i) Bachelor's Degree from a recognized University or equivalent; **and**

(ii) 5 years' provided 3 years' experience in the field of intelligence collection.

Note-1: The actual requirement of officers belonging to different categories on deputation will be decided by Director, Intelligence Bureau at the time of each selection.

Note-2: Indian Police Service officials shall draw pay and allowances as per Indian Police Service (Pay) Rules.

Note-3: Deputation of All India Service officers shall be regulated in terms of the relevant Service Tenure Rules.

Note-4: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Note-5: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Govt. shall ordinarily not to exceed three years.

Note-6: The maximum age-limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of applications.

2. Assistant Central Intelligence Officer-I/Executive (54 vacancies), General Central Service (Group-B), Non-Gazetted, Non-Ministerial in level 8 of the Pay Matrix (Rs. 47,600-1,51,100).

Eligibility: Deputation/Absorption:

Officers under the Central Police Organizations or State Police Organizations or Defence Forces:

a) (i) holding analogous post on regular basis in the parent cadre or department; **or**
(ii) with two years' service in the grade rendered after appointment thereto on a regular basis in level 7 (Rs. 44,900-1,42,400) in the pay matrix or equivalent in the parent cadre or department; **and**

b) possessing the following educational qualifications and experience:

(i) Bachelor's Degree from a recognized University or equivalent; **and**

(ii) 2 years' experience in security or intelligence work.

Note-1: The departmental officers in the feeder category, who are in the direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Note-2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Govt. shall ordinarily not exceed 3 years.

Note-3: The maximum age-limit for appointment by deputation or absorption shall be not exceeding 56 years as on the closing date of receipt of applications.

Note-4: For the purpose of appointment on deputation or absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 or the date from which the revised pay structure based on the 7th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the said Pay Commission.

2. Officers, who fulfill the above mentioned conditions of eligibility may submit their applications to their employers, who may forward the same alongwith the following papers/documents so as to reach the **Joint Deputy Director/G, Intelligence Bureau, Ministry of Home Affairs, 35, S.P. Marg, New Delhi-21 within 60 days** from the date of issuance of this Advt.

(i) Bio-data in the prescribed proforma (as per Annexure-A) in duplicate duly signed by the candidate and forwarded through proper channel;

(ii) Copies of APAR/ACRs for the last 5 years attested on each page by an officer not below the rank of Under Secretary;

(iii) Vigilance Clearance Certificate;

(iv) Integrity certificate;

(v) A statement of major/minor penalty, if any, imposed on the officer during the last 10 years;

(vi) Cadre Clearance Certificate.

3. Applications complete in all respect duly forwarded through proper channel only will be entertained. Applications received in advance or after the last date or without all or any of the above documents or otherwise found incomplete will not be considered and no correspondence will be made or entertained in this regard. The officers who apply for the post will not be allowed to withdraw their candidature subsequently.

4. The officer inducted/selected to these posts will be on deputation for a period as specified in the induction order. This period can be curtailed or extended if exigencies of service so require. Deputation will be governed by the terms of deputation as laid down in the DoPT OM No. 6/08/09 (Estt) (Pay-II) dated 17.6.2010, as amended from time to time.
