Important Instructions

1. Interested and eligible candidates are requested to fill the prescribed Application Form and bring the same alongwith their original certificates and testimonials for personal interview/discussion as per the schedule indicated above. Candidates are also required to bring Self attested Photo copies of relevant degree & experience certificate, passport size photograph alongwith proof of identification at the time of Interview, failing which they shall not be allowed to appear in Interview.
2. Applicants must fully satisfy themselves about their eligibility as prescribed in the advertisement, before appearing in the Interview. If an applicant is inadvertently allowed to appear in the Interview who otherwise does not fulfill the minimum eligibility requirements, he/she cannot, at a later date, use that as right to claim that he/she meets the eligibility requirements. If at any stage it is found that documents are not correct the candidature will be cancelled irrespective of the stage of process.
3. Any corrigendum/changes/updates on recruitment process shall be made available on the Institute website only. No separate/ individual communication shall be sent. The candidates are strictly advised to keep in touch with the Institute's website for updates, if any.
4. The services of Guest Faculty shall be liable to termination at any time by a notice in writing given either by the Guest Faculty to the appointing authority, or by the appointing authority to the Guest Faculty. The period of such notice shall be one month, unless otherwise agreed to by the Institute and the Guest Faculty. The other terms and conditions of the service shall be specified in the letter of appointment.
5. Vacancies of PwD(Persons with Disabilities) quota are horizontal and included in the total number of vacancies. Therefore, there will be no separate recruitment against PwD quota and it will be conducted simultaneously and adjusted against UR/SC/ST/OB(NCL) category to which the candidates belong.
6. Candidates belonging to Other Backward Classes (Non Creamy Layer) [OB (NCL)] category should submit proper caste certificate as per the proforma of Government of India (which should not be more than 6 months old from the date of Interview) and which should among others specifically mention that he/she does not belong to the persons/sections (creamy layer) as mentioned in the Department of Personnel & Training, O M. No. 36033/1/2013-Estt. (Res), dated 13.09.2017. Candidates belonging to OB category, but coming in creamy layer will not be entitled to the benefits of reservation and should apply as UR (unreserved) category candidates.
7. Candidates belonging to Scheduled Casts(SC) or Scheduled Tribes (ST) must bring category certificate.

8. The selection Committee will make the merit list based on performance in the interview on common consensus basis and draw a merit list of the successful candidates in the interview from each category. If required, the selection Committee may also draw a waiting list with sufficient number of eligible candidates from each category. The results of the interview shall be notified through Institute website after approval of the competent/appointing authority. No correspondence shall be entertained during the process of the selection.
9. The number of vacancies advertised may change, Institute also reserves the right to withdraw any advertised post(s) at any time without assigning any reason. Further, the Institute has right not to fill the vacancy/vacancies and no correspondence in this regard will be entertained. Canvassing in any form and/or bringing any influence, political or otherwise, will be treated as disqualification for the post applied.
