Applications are invited from Ex-servicemen and retired officers (under VRS) from Central & State Government/PSUs for engagement as Operational Consultant on short term basis in North East Region, BBNL Corporate Office at New Delhi and in other BBNL States for existing vacancies or where the vacancies are likely to arise in next one year

- 2. Those applying for BBNL states (other than corporate office and NER) (post code 06), will indicate their two preferences for the states. A common pool for deployment in BBNL states will be prepared, with highest ranked candidate (preference 1 and 2) will be offered work for the particular state on the basis of availability of vacancy in that state. The vacancy will be either in State Capital or another major town / city in the state. Similary, a common list for Corporate Office (post code 07) will also be prepared. For NER the clear vacancy for 5 states exist (post code 01 to 05). Those applying for North East Region will also have to give two choices of states and the deployment will be based on suitability and preference for the states.
- 3. The terms and conditions for engagement as operational consultants are mentioned below:
  - a. Candidate should be less than 58 years of age as on date of notification.
  - b. The candidate shall be appointed on a short-term contract basis initially for a period of 6 months. Based on his/her performance and requirement of his/her services, the contract can be further extended up to a maximum of Six Terms (6 months each) or 60 years of age whichever is earlier.
  - c. The consolidated per month fee/remuneration of Consultants shall be restricted to the difference between last pay drawn by him and his basic pension+ DA at the rate applicable from time to time.
  - d. The Income Tax or any other tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment for which BBNL will issue TDS certificates.
  - e. The engagement can be terminated by either of the party with prior notice of 30 days.
  - f. Regular right of employment is not there nor may such person claim such right in any circumstances.
  - g. The engagement of Ex-servicemen and other retired officers would be done through a selection committee and its concomitant process. The selection committee would be constituted by BBNL.
  - h. The engaged Operational Consultant (s) would be given a designation of CGM (Project)/ Sr. GM (Project)/ GM (Project).
  - i. TA/DA and other allowances & facilities will be as per BBNL policy.

Interested Ex-servicemen and retired officers (under VRS) from Central & State Government/PSUs may send their application in the proforma enclosed.
