III. Permanent Residence Certificate:

The candidates applying for the post should produce the permanent residence certificate by concerned MRO / Tehsildar of the mandal *to which sub center and PHC they have applied*

IV. Method of selection:

Based on the marks obtained in qualifying exam ie., 18 months MPHWF Training certificate recognized by the AP Nursing and Midwives Council OR Two years Intermediate Vocational Multi Purpose Health Worker (F) Course (**Marks obtained in vocational subjects only**)

V. Local / Non Local:

The MPHWS (F) is a district cadre and local reservations are applicable as per existing rules. However the Govt have put a condition that permanent residents of particular Mandal are only eligible to apply for posts in that Mandal. Therefore, the first criterion that is "local candidates" must be satisfied at the District level. Up to a minimum of 80% of Local candidates belonging to that District. However, whether a candidate is "local" or "non-local" as per the definition under the Presidential Order, they should also satisfy the compulsory "Permanent Residence in that Mandal" criterion. Hence, candidates applying for a mandal should submit "Permanent Residence Certificate" of that mandal issued by the MRO / Tahsildar, in addition to "local" certificate of the district, if they are claiming local status.

VI. Priority to the candidates residing in same sub center area to which sub center they are applying.

The candidates should be residing in the same sub center area. If candidates are not available in the sub centre area, they should be selected from that mandal and if not available even in that mandal, they will be selected from the nearest area in the district until the candidates belongs to the sub centre are become available (para 3 of G.O.Rt.No.971 HM&FW (D1) Dept., Dt.25.07.2008).

VII. Reservation:

- 1) As per the Mandal wise break up of reservations enclosed along with this notification. However it must be strictly ascertained that, **vacancies falling in the Scheduled Areas should invariably be filled by the Scheduled Tribe Candidates only** (para 4 of G.O.Rt.No.971 HM&FW (D1) Dept., Dt.25.07.2008).
- 2) **The post allotted to one community shall not be filled by other community** (para 2 of R.No.4544/FW-E1/2008, Dt.10.10.2008 of the CH&FW., A.P., Hyderabad).
- 3) The recruitment is taking the Mandal as a unit and as per the roster points allotted to that particular Mandal. There may be one PHC in a Mandal or more PHCs as per the 2nd ANM Vacancies.
- 4) The Roster Points are starting from 518 to 596 (79 points/79 posts). The Rosters points are started from 518 because the previous 2nd ANM recruitment in the year 2007-08 was ended with Roster Point No. 517.

VIII. Physically Handicapped:

Reservation applies to the physically handicapped as per rules.

IX. HOW TO APPLY:

- b) Filled in application forms shall be submitted in person or through post to the Rogi Kalyana Samithi, Medical Officer Concerned PHC to reach on or before 04.09.2018 by 4.00 P.M. Applications which are received after due date will be summarily rejected and not responsible for postal delays.

NOTE:

- 1) Application which are not having up to date renewals of respective Council/ Board will be summarily rejected.
- 2) If attested copies of Cast certificate/Physically handicapped certificate/Ex-Servicemen certificate not enclosed the candidate will be treated under O.C
- 3) If Certificate copy of permanent residence certificate and study certificate is not enclosed, the candidate will be treated as non local.
- 4) If attested copies above are not enclosed, the application will be summarily rejected.

X. Conditions on Appointment:

The candidate selected and appointed on outsourcing basis shall not be regarded as a member of the service in which the post to which she is appointed, is included, and shall not be entitled by reason only of such appointment, to any preferential right to any other appointment in that or any other service. The department or the person may revoke the outsourcing appointment or discontinue the contract by giving one month's notice in writing on either side. This contract would automatically cease to operate on lapse of contract period and both parties will be discharged of their respective obligations and liabilities without any formal or informal communication.

TENURE :- Initially for a period of one year from date of joining in the post.

XI. Other service condition:

All persons appointed on contract basis shall execute an agreement on a non-judicial stamp paper of Rs.100/- with two witnesses, and submit the same to the appointing authority concerned at the time of reporting for duty, agreeing to the terms and conditions of the contract

XII. Recruitment Schedule:

XIII. DEBARMENT:

1. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment and future recruitments.
2. The department is vested with conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Department will be sufficient cause for rendering such questionable means as ground for debarment.

XIV. DEPARTMENT'S DECISION IS FINAL:

The decision of the department pertaining to the application and its acceptance or rejection as the case may be, and conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned under the powers vested with it. The department/DSC also reserves its right and modify regarding terms and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process. The Department is empowered to increase or decrease the total vacancies notified subject to availability of vacancies as on the date of selection.
