E. Mode of Application

Online Registration

1. All Applicants shall apply on fulfilling the required criteria by submitting their applications in the Website: www.bankura.gov.in through ONLINE submission along with their recent passport size colour photograph and signature.

2. One candidate can apply for only one category of post. Multiple applications for more than one category of post or submission of more than one application for a single post is strictly forbidden and will lead to rejection of the candidature of the candidate.

3. A unique registration number will be generated on successful submission of application form after filling-up of relevant columns.

- 4. This registration number shall be preserved for any future reference and generation of Admit Card etc.
- 5. After filling-up and submission of the Application form properly, a print out of online application form shall be taken for future reference if required.
- 6. The particulars furnished by the applicant in the application form shall have to be self-attested.
- 7. While filling-up the Application Form, candidates are required to upload scanned copy of their recent passport size color photograph in **ipg format** (taken within 6months) of size 10 KB to 30 KB.
- 8. Candidates are also required to upload scanned copy of their full signature in **jpg format** of size not exceeding 10 KB.
- 9. Photocopies of the testimonials of the candidate shall not be attached with the application format.

- 11. Examination for each of the above mentioned contractual posts will be held simultaneously.

- 5. The lower part of the Admit is to be signed by the applicant in presence of the invigilator on the day of examination and to be handed over to the invigilator.
- 6. The candidate shall have to bring with him/her any photo identity document viz. EPIC, PAN Card, Passport, Admit Card / Certificate of Madhyamik or equivalent with photograph / Driving License/ Bank Pass Book containing Photograph of the candidate / any other photo identity card issued by the competent Govt.
