ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT (MBBS):-

- 1. Qualifications:-** MBBS degree from recognized University/Institute must have valid registration certificate with Delhi Medical Council. Candidate must not have completed one year Junior Residency from any recognized institution of India including regular or ad-hoc basis.
- 2. Internship:-** The candidate is having completed compulsory rotating internship after 01.03.2017.
 - Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the Interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions (vide Circular No. F. 121/26/2010/H & FW/1996-2045 dated 10.06.2011).
 - Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Jr. Residents, if fresh graduates are not available.
- 3. Pay Scale Junior Resident:-** Pay matrix of Level-10(Rs. 56100-177500)+NPA+ and other admissible allowances per month.
- 4. Age Limit for Junior Residents** -As on 01.03.2019 shall be 40 years for General candidates, 45 years in case of SC/ST and 43 years in case of OBC candidates in accordance of circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi.
- Candidates applying for OBC category, the certificate must be issued by the competent authority of Govt. of NCT of Delhi.
- Hostel Accommodation is compulsory for Junior Residents. No HRA will be paid if the candidate stays outside.
- Appointment will be subject to verification of certificates of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- There is no fee for appearing in the Interview. No TA/DA will be given for appearing in interview.

Reservation for Person with disabilities candidates / Differently abled persons shall be as per rules of Govt. of India.

10. Jurisdiction of- Dispute in case of any legal dispute the jurisdiction of Court will Delhi/New Delhi only.

11. All the eligible candidates should report in the office of the under signed (Time for registration from 9:00AM to 11:30 AM only).

12. In case of non availability of suitable SC/ST/OBC candidates shall be filled on ad-hoc basis from other category & vice-versa for smooth functioning of patient care service.

13. Candidate must submit their Bio-data with photo copy of certificate, one photograph and original documents should be shown at the time of interview.

14. *Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertised before appearing in the interview.*

15. Candidates who are presently working on ad-hoc basis in this hospital will have to apply a fresh in response to this advertised.
