## ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT (MBBS):-

- 1. Qualifications: MBBS degree from recognized University/Institute must have valid registration certificate with Delhi Medical Council. Candidate must not have completed one year Junior Residency from any recognized institution of India including regular or ad-hoc basis.
- 2. <u>Internship:</u> The candidate is having completed compulsory rotating internship after 01.03.2017.
  - Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the Interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available.
